Submissions due April 23 & 24, 2012

Eligibility: FVAC seeks innovative, imaginative, creative artists, painters, sculptors, photographers, print makers, illustrators, collage artists to participate in the 2012 Spring Open Juried exhibit of contemporary works, **Connections...**

Awards: Fisher Award of Excellence - Prize : 2013 Solo Show in the Fisher Gallery
First Runner-Up - Prize : \$100 Supplies Gift Certificate TBA
Honorable Mention - Prize : \$50 Supplies Gift Certificate TBA.

Opening & Awards Reception: May 4, 6-8:00 pm All entry artists are encouraged to attend.

Submissions: Paintings, drawings, prints, photography, collage, mixed media and sculpture. All works must be framed with mechanics ready to hang or mount for display.

Size limits: 2-dimensional pieces not to exceed 48" h x 48" w 3-dimensional pieces not to exceed 20" sq (base) x 60" h and not to exceed 100 lbs

Delivery: Work must be delivered to FVAC Fisher Gallery, 25 Arts Center Lane, Avon, CT on Monday, April 23, 9 am - 3 pm, or Tuesday, April 24, 9 am-3 pm

Notification: Will occur by e-mail or mail.

Return: Declined work must be picked up on April 30, 9 am - 3 pm Accepted, unsold work must be picked up on June 5, 9 am - 3 pm

Requirements: Artists whose work is selected must meet the following requirements: Work must be available for sale, with a 40% commission payable to FVAC. Award recipients must be available for May 4 ceremonies. By entering this exhibition the artist agrees to make information regarding the work available for publicity.

Fees: \$20 for each entry, limit 3 pieces. FVAC members 1st entry \$10

FVAC reserves the right to display or refuse work for any reason.

Entry Procedure - Assemble:

- Art Work, Attach entry form to each, \$20 Check (payable to: FVAC) or cash for each piece
- Brief artist statement
- Self addressed stamped envelope
- Optional / Digital Image of artwork for use in FVAC publicity, due April 1, 2012
